This Recognition Notice is being granted in terms of article 22 of the Gaming Authorisations Regulations (S.L. 583.05) (the 'Regulations'), issued under the Gaming Act (Chapter 583 of the Laws of Malta) (the 'Act'), by the Malta Gaming Authority (the 'Authority').

TERMS AND CONDITIONS

- (i) The Recognition Notice shall come into effect on **21 August 2026** (the 'Effective Date').
- (ii) This Recognition Notice is being issued on the basis that the MGA recognises that the holder is authorised to provide its gaming services, critical gaming supply, key function, or other activity requiring an authorisation in Malta in terms of the Regulations, by virtue of the licence/s issued to the holder by the competent authority of a recognised jurisdiction, specifically the licence/s listed in Annex A;
- (iii) This Recognition Notice is hereby being granted by the Authority, and remains valid for as long as the licence/s listed in Annex A remain valid, unless otherwise revoked, suspended, cancelled or terminated;
- (iv) This Recognition Notice may be revoked by the Authority on the same grounds as any other authorisation issued by the Authority;
- (v) The holder of this Recognition Notice shall pay the applicable administrative fee listed in the Fourth Schedule of the Gaming Licence Fees Regulations (S.L. 583.03), annually and in advance, and failure to pay such annual fee shall result in the automatic lapse of this Recognition Notice;
- (vi) The holder of this Recognition Notice shall provide reports to the Authority in the format stipulated by it for the payment of gaming tax as required according to the Gaming Tax Regulations (S.L. 583.10), and the payment of such gaming tax whenever it is due;
- (vii) Failure to pay the administrative fees, or gaming tax due shall constitute grounds for revocation of this Recognition Notice;
- (viii) The holder of this Recognition Notice shall:
 - Inform the Authority forthwith of the termination, suspension, or revocation of any of the licence/s listed in Annex A;
 - Inform the Authority forthwith, and provide the relevant documentation required in order to recognise the addition of new licence/s;
 - Operate solely within the parameters allowed by the licence/s mentioned in Annex A;
 - Provide any information, data, statistics or reports as may be required by the Authority; and
 - Comply within any applicable regulatory instrument, including binding instruments issued by the Authority.
- (ix) This Recognition Notice is being granted subject to all the provisions of the Act, the Regulations and all other regulatory and binding instruments, as well as any other law which may be applicable from time to time.
